3. The quorum to constitute a meeting of the Committee shall be one-fourth of the total membership of the Committee.

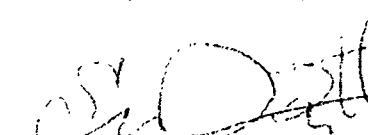
