No. SOIII(SWD)14-48/Amendments/2018/PC In exercise of the powers conferred by sub-section (1) of section 62 of the Khyber Pakhtunkhwa Child Protection and Welfare Act, 2010 (Khyber Pakhtunkhwa Act No. XIII of 2010), the Government of the Khyber Pakhtunkhwa is pleased to direct that in the Khyber Pakhtunkhwa Child Protection and Welfare rules, 2016, the following amendments shall be made, namely:

**AMENDMENTS**

In rule 32-

(i) for sub-rule (1), the following shall be substituted, namely:

"(1) The Committee shall consist of seven (7) members, with three of its members from the Social Welfare, Special Education and women Empowerment Department, the Establishment Department and the Finance Department, while four (4) members shall be non-official " and

(ii) for sub-rule (2), the following shall be substituted, namely:

"(2) The non-official members shall be appointed and notified by Government, who shall-

(a) be a bonafide resident of the Province;

(b) not be more than sixty five (65) years of age;

(c) have at least Master's Degree from a recognized University and at least five (5) years' experience in a public or private sector institution or agency, dealing with the issues connected with protection and welfare of children; and

(d) not be employed in a Government or semi-Government organization, as the case may be "
