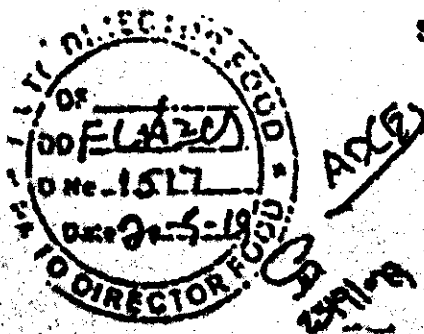

Subject:- S.N.E FRESH PROPOSAL FOR MERGED DISTRICTS

Dear Sir,

I am directed to refer to this department letter No. SOG/Food/1-44(A)/2017/4238 dated 01-08-2019 on the subject noted above and to state that due to placement of employees of Food Cell of ex-FATA Secretariat under Food Department, Khyber Pakhtunkhwa vide Establishment Department Notification No.SO(E-I)/E&AD/9-126/2018 dated 11-12-2018 (copy enclosed) the following anomalies are noticed:-

S.No.	Nomenclature of the post with BPS	Remarks
1.	Assistant Director Food (BS-17)	As per existing setup no such post is available at district level, therefore, the nomenclature of the post may be changed to District Food Controller (BS-17)
2.	Assistant Accounts Officer (BS-17)	As above.
3.	District Food Controller (BS-16)	The post of District Food Controller is BS-17, therefore the post may be redesignated as Assistant Food Controller (BS-16) and the incumbant of post be adjusted in other department.
4.	Computer Operator (BS-16)	The official could be adjusted against one post of Computer Operator (BS-16) of merged districts.
5.	Senior Clerk (BS-14)	Three (03) officials of Food Cell could be adjusted against 03 posts of merged district.
6.	Junior Clerk/ Store Keeper (BS-11)	Four (04) officials of Food Cell could be adjusted against 04 posts of merged district.
7.	Assistant Food Controller (BS-08)	The post of Assistant Food Controller in Food Department is in BS-16, therefore the Five (05) officials of Food Cell may be adjusted in other departments and the post be upgraded to BS-16.
8.	Driver (BS-07)	May be adjusted in Food Department under the administrative control of Secretary Food.
9.	Chowkidar (BS-3)	Sixteen (16) officials of Food Cell could be adjusted against the 16 posts of merged districts.
10.	Naib Qasid (BS-03)	Two (02) officials of Food Cell could be adjusted against the 02 posts of merged districts.
