

**LIST OF PROPOSED AMENDMENTS IN THE KHYBER
PAKHTUNKHWA MEDICAL OFFICERS OF HEALTH DEPARTMENT
(REGULARIZATION OF SERVICES) BILL, 2022.**

CLAUSE-3

1. **Mr. Ahmad Kundi, MPA** to move that in clause-3, after the words “till the commencement of this Act”, the words and figure “or 30th June, 2022” may be inserted.

2. **Ms. Nighat Yasmeen Orakzai and Mr. Mir Kalam Wazir, MsPA** to move that in clause-3, for the words “day of commencement of this Act”, the words “date of their initial appointment on contract basis” may be substituted.

3. **Mr. Ahmad Kundi, MPA** to move that in clause-3, for the words “from day of commencement of this Act”, the words “from the date of their initial appointment” may be substituted.

4. **Mr. Ahmad Kundi, MPA** to move that in clause-3, the existing provision may be numbered as sub-clause (1), and thereafter, the following new sub-clause (2) may be added namely,-

“(2) The Medical Officers whose services are regularized under the Act, shall be entitled to receive such pension/gratuity as admissible to Civil Servants before the commencement of the Khyber Pakhtunkhwa Civil Servants (Amendment) Act, 2022. (Khyber Pakhtunkhwa Act No. X of 2022).”

5. **Ms. Asiya Asad, MPA** to move that in clause 3, the existing provision against the heading “**Regularization of services of Medical Officers.---**” may be renumbered as sub-clause (1) and thereafter, the following new sub-clause (2) may added, namely,-

“(2) The Medical Officers, whose services are regularized under this Act, shall:

- (i) in lieu of pension and gratuity, be entitled to participate in the Contributory Provident Fund, as provided in sub-section (2) of section 19 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973) and rules made thereunder; and
- (ii) in lieu of seniority and pay, be entitled to calculation of the same effective from the date of initial ad-hoc appointment.”

CLAUSE-4

Ms. Nighat Yasmeen Orakzai and Mr. Mir Kalam Wazir, MsPA to move that in clause 4, after the heading “**General conditions for regularization.--**” the existing provision may be renumbered as sub-clause (1), and thereafter, the following new sub-clause (2), may be added, namely,-

“(2) Notwithstanding anything contained contrary in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973) and rules made thereunder, the Medical Officers, whose services are regularized under this Act, shall be entitled to receive such pension or gratuity, as were admissible to civil servants before the commencement of the Khyber Pakhtunkhwa Civil Servants (Amendment) Act, 2022 (Khyber Pakhtunkhwa Act No. X of 2022).”

CLAUSE-5

Ms. Asiya Asad, MPA to move that in clause 5, sub-clause (1) may be deleted and thereafter the remaining sub-clause may be renumbered, accordingly.

CLAUSE-6

Mr. Ahmad Kundi, MPA to move that in clause-6, after the words “Chief Minister”, the words “and Secretary of the Department” may be inserted.
