No.PA/KhyberPakhtunkhwa/Legis-I/2019/ 17845 In exercise of the powers conferred on me by rule 250 of the Provincial Assembly of Khyber Pakhtunkhwa, Procedure and Conduct of Business Rules 1988, I do hereby authenticate the under mentioned amendments in the Provincial Assembly of Khyber Pakhtunkhwa, Procedure and Conduct of Business Rules, 1988 as unanimously passed by the House, in its sitting, held on 24th December, 2019:-

1. **Sub-rule (1) of rule 154 shall be substituted by the following, namely:**

154. Composition.- (1)Each Committee shall consist of not more than thirteen members, to be elected by the Assembly, in addition the Minister-in-Charge shall be ex-officio member of the Committee.The election shall be held within sixty days after the election of the Leader of the House, in accordance with the procedure agreed to by the leaders of the parties in the Assembly, failing which by non-transferable vote.”

2. **Rule 162 shall be substituted by the following namely:-**

162. Composition of the Committee.-The Committee on Procedure and Conduct of Business Rules, Privileges and Implementation of Government Assurances shall consist of thirteen members to be elected by the Assembly, in addition the Deputy Speaker shall be ex-officio Chairperson of the Committee and the Minister for Law, Parliamentary Affairs and Human Rights shall be its member ex-officio.”

3. **Rule 163-A shall be substituted by the following namely:-**

163-A. Composition of the Committee.-(1) There shall be a Committee for Law Reforms and Control on Subordinate Legislation.

(2) The Committee shall comprise of twelve members from amongst lawyers, ulamas and technocrats who are Members of the Assembly.”

4. **Rule 164 shall be substituted by the following namely:-**

164. Composition of the Committee.- The Judicial Committee shall comprise of twelve Members, in addition the Minister for law, Parliamentary Affairs and Human Rights shall be its Member ex-officio.”

5. **Rule 166 shall be substituted by the following namely:-**

166. Composition of the Committee.- The House and Library Committee shall comprise of ten Members, in addition the Deputy Speaker shall be its ex-officio Chairperson.”
