BILL**

to repeal the Razmak Cadet College Regulation, 1977.

WHEREAS, it is expedient to repeal the Razmak Cadet College Regulation, 1977 (Regulation No. II of 1977), for the purposes hereinafter appearing;

It is hereby enacted as follows:

1. Short title and commencement.---(1) This Act may be called the Pakhtunkhwa Razmak Cadet College Regulation (Repeal) Act, 2019.

(2) It shall come into force at once.

2. Definitions.--- In this Act, unless the context otherwise requires,-

(a) "assets" means anything of the value and includes but is not limited to property whether tangible or intangible, cash investments, accounts receivables, loans granted, inventory, vehicles, furniture, which is under the administrative control of the College before the commencement of this Act;

(b) "College" means the Razmak Cadet College established under section 3 of the repealed Regulation and to be governed in accordance with the provisions of section 4 of this Act;

(c) "record" means any information, documents, ledgers, books, accounts, data, dossiers, files, reports, archives, notes, minutes, transactions, proceedings, transcripts, logs, inventory lists, catalogues or otherwise anything that may be determined by the College to be record of the College;

(d) "repealed Regulation" means the Razmak Cadet College Regulation, 1977 (Regulation No. II of 1977) as repealed under section 3 of this Act; and

(e) "Training Institutions Ordinance" means the Khyber Pakhtunkhwa Government Educational and Training Institutions Ordinance, 1971 (Khyber Pakhtunkhwa Ordinance No. III of 1971).

3. Repeal.--- On commencement of this Act, the Razmak Cadet College Regulation, 1977 (Regulation No. II of 1977) is hereby repealed.

4. Application of the Khyber Pakhtunkhwa Ordinance No. III of 1971 to the College.---Upon repeal of the Razmak Cadet College Regulation, 1977, under section 3 of this Act, the affairs of the College shall be governed in accordance with the provisions of Training Institutions Ordinance.

5. **Savings.**---(1) On commencement of this Act, all assets, liabilities records, bank accounts, properties, debts, obligations, claims and proceeding before judicial forums of the College shall continue to be the assets, liabilities, records, bank accounts, properties, debts, obligations, claims and proceedings of the College.

(2) The Fund established under section 10 of the repealed Regulation shall continue to be the part of the fund to be constituted under the provisions of the Training Institutions Ordinance.

(3) All actions taken, orders issued, rules made, notifications issued, contracts signed and appointments made under the repealed Regulation, till the commencement of this Act, shall continue to remain inforce until repeal or amend by the competent authority.

6. **Removal of difficulties.**--- If any difficulty arises in giving effect to any of the provision of this Act, the Government of Khyber Pakhtunkhwa may pass any order, not inconsistent with the provisions of this Act, as may be deemed necessary for the purpose of removing such difficulty.

STATEMENT OF OBJECTS AND REASONS

It is desirable to repeal the Khyber Pakhtunkhwa Razmak Cadet College Regulations Act, 1977 (Regulation No. II of 1977). Hence, this Bill.
