CLAUSE-3

Malik Zafar Azam MPA to move that in clause 4, in the proposed section 4A, in sub section (1), for the words “all of whom shall be from the private sector”, the words “two members shall be from the Government sector and three members from private sector out of five members or three members shall be from Government sector and four from private sector out of seven members, as the case may be” may be substituted.
