further to amend the Khyber Pakhtunkhwa  
Emergency Rescue Service Act, 2012.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa  
Emergency Rescue Service Act, 2012 (Khyber Pakhtunkhwa Act No. XV of  
2012), for the purposes hereinafter appearing;

It is hereby enacted as follows:

1. **Short title and commencement.** --- (1) This Act may be called the Khyber  
Pakhtunkhwa Emergency Rescue Service (Amendment) Act, 20~~10~~<sup>20</sup>.

(2) It shall come into force at once.

2. **Amendment of section 13 of the Act No. XV of 2012.**---In the said Act, in  
section 13,-

(a) in sub-section (3),-

(i) for clause (a), the following shall be substituted, namely:

“(a) is a Medical Graduate preferably a Post Graduate or  
having Master’s Degree in Disaster Management,  
Emergency Management, Public Health, Business  
Administration (MBA) or Public Administration  
(MPA) or Bachelor of Business Administration (BBA,  
Hon's) (16-years of Education) or B.Sc. Engineering in  
Civil, Mechanical or Electrical;” and


(ii) in clause (b), after the words “emergency management”, the  
words “and administration” shall be inserted;

(b) in sub-section (4),-

(i) for clause (a), the following shall be substituted, namely:

“(a) is a Medical Graduate preferably a Post Graduate or  
having Master’s Degree in Disaster Management,  
Emergency Management, Public Health, Business  
Administration (MBA) or Public Administration  
(MPA) or Bachelor of Business Administration (BBA,  
Hon's) (16 years of Education) or B.Sc. Engineering  
in Civil, Mechanical or Electrical;” and

(ii) for clause (b), the following shall be substituted, namely:

“(b) has at least two years working experience in the relevant field preferably in Health Management, Emergency Management or Administration; and”.
