Dear Sir,

I am directed to say that the Provincial Assembly of Khyber Pakhtunkhwa in its sitting held on **25-05-2021** unanimously passed the following Resolution No.1151 moved by Mr. Inayatullah, Member Provincial Assembly Khyber Pakhtunkhwa as follow:-

یہ اسمبلی صوبائی حکومت سے سفارش کرتی ہے کہ وہ مرکزی حکومت سے اس امر کی سفارش کرے کہ چونکہ 2017ء کی مردم شماری کو CCI نے منظور کیا ہے۔ جسکی وجہ سے سابقہ فائنا کا انضمام اور خیبر پختونخوا کے آبادی میں اضافہ کی وجہ سے قابل تقسیم محاصل Disable Pool میں خیبر پختونخوا کا حصہ 14 فی صد سے بڑھ کر 19 فی صد سے بھی تجاوز کر گیا ہے۔ اس لئے مرکزی حکومت خیبر پختونخوا کے حصہ کو revise کرے اور آبادی میں اضافہ کے مطابق نیشنل فنانس کمیشن (NFC) میں ہمارے حصے کا دوبارہ تعین کرے اور آبادی کی بنیاد پر ہمارا حصہ آنے والے مالی سال میں ہمیں فراہم کرے اس سے خیبر پختونخوا میں غربت کے خاتمے اور پائیدار ترقی کی راہ ہموار ہو جائیگی۔
