لہذا یہ اسمبلی صوبائی حکومت سے سفارش کرتی ہے کہ وہ وفاقی حکومت سے اس امر کی سفارش کرے کہ قبائلی اضلاع کے کونے کونے میں موبائیل اور انٹرنیٹ کی سہولت ہنگامی اور جنگی بنیادوں پر فراہم کیا جائے۔ تاکہ وہاں کے عوام زندگی کے ایک بنیادی ضرورت اور سہولت سے مستفید ہو سکیں۔
