Moved by Mr. Akbar Ayub Khan, Minister for Elementary and Secondary Education,

WHEREAS the Federally Administered Tribal Areas Development Authority Regulation (Repeal) ordinance, 2020 (Khyber Pakhtunkhwa Ordinance No.VII of 2020) has been promulgated by the Governor on 20th of April, 2020 and the said Ordinance will expire on the 18th of July, 2020.

AND WHEREAS the first Proviso to Clause (2) (a) of Article 128 of the Constitution of the Islamic Republic of Pakistan provides that the Provincial Assembly may by resolution extend the ordinance for a further period of 90 days:

NOW, THEREFORE, the Provincial Assembly of Khyber Pakhtunkhwa in terms of the first Proviso to Clause (2) (a) of the Article 128 of the Constitution of the Islamic Republic of Pakistan hereby resolves to extend the Federally Administered Tribal Areas Development Authority Regulation (Repeal) Ordinance, 2020 (Khyber Pakhtunkhwa Ordinance No.VII of 2020) for a further period of 90 days.
