

**LIST OF PROPOSED AMENDMENTS IN THE KHYBER PAKHTUNKHWA EDUCATION MONITORING AUTHORITY BILL, 2019.**

**CLAUSE 2**

**Mr. Khushdil Khan, MPA** to move that in clause 2, for paragraph (r) the following may be substituted namely;

“(r) “secondary education” means education from Class IX to Class XII; and”

**CLAUSE 3**

**1. Mr. Khushdil Khan, MPA** to move that in clause 3, for sub-clause (1), the following may be substituted, namely;

“(1) After the commencement of this Act, the Government shall established an Authority, to be known as the Khyber Pakhtunkhwa Education Monitoring Authority, headed by the Director General with four members one of the members shall be a female whose selection shall be made from retired officers of grade 18 or 19 of the Department in a transparent manner.”

**2. Mr. Khushdil Khan, MPA** to move that in clause 3, after sub-clause (1), the following new sub-clause (2) may be inserted and thereafter the remaining sub-clauses may be renumbered accordingly,-

“(2) The appointment of the members of the Authority shall be made on contract basis for a period of three years not extendable further and shall be entitled to such emoluments as may be prescribed.”

**CLAUSE 6**

**Mr. Khushdil Khan, MPA** to move that for clause 6, the following may be substituted, namely;

“**6. Transaction of Business of the Authority.** --- Business of the Authority shall be allocated and transacted in such manner as may be prescribed.”

**CLAUSE 7**

**1. Mr. Khushdil Khan, MPA** to move that in clause 7, for sub-clause (1), the following may be substituted, namely;

“(1) The Authority shall establish, control, run and continuously improve an effective system of monitoring of entities under this Act.”

**2. Mr. Khushdil Khan, MPA** to move that in clause 7, in sub-clause (2), in paragraph (i), after the word “working”, the words “and performance” may be inserted.

### **CLAUSE 10**

**Mr. Khushdil Khan, MPA** to move that clause (10) may be deleted.

### **CLAUSE 11**

1. **Mr. Khushdil Khan, MPA** to move that in clause 11, in sub-clause (1) after the word “employ”, the words “on merit basis” may be inserted.
2. **Mr. Khushdil Khan, MPA** to move that in clause 11, in sub-clause (2) for the words “directions of the Director General”, the words “rules and written instructions of the Authority” may be substituted.

### **CLAUSE 13**

**Mr. Khushdil Khan, MPA** to move that in clause 13, after sub-clause (4), the following new sub-clause (5) may be added, namely;

“(5) The Government shall present the annual report of the Authority to the Provincial Assembly of Khyber Pakhtunkhwa.”
