I am directed to say that the Provincial Assembly of Khyber Pakhtunkhwa in its sitting held on **12-04-2021** unanimously passed the following joint Resolution No.1062 moved by Mr. Waqar Ahmad Khan and Mr. Shaukat Ali Yousafzai, Minister for Labour, Member Provincial Assembly Khyber of Pakhtunkhwa as follows:-

لہذا یہ اسسٹنٹ سیکریٹری صوابی حکومت سے سفارش کرتی ہے کہ وہ وفاقی حکومت سے اس امر کی سفارش کرے کہ وفاقی حکومت اس ظالمانہ تضاد کو ختم کرے اور فی الفور ٹول ٹیکس کے ریٹ میں مزید کمی لانے کے لیے مناسب اقدامات کریں۔
