لہذا یہ اسمبلی صوبائی حکومت سے سفارش کرتی ہے کہ صوبہ خیبر پختونخوا کے تمام مجرمان جو کہ بچوں کے اغوا، جنسی درندگی اور (Sexual Harassment) میں ملوث ہیں ان کا ایک (Centralized Data) محفوظ کیا جائے جس سے ان مجرمان تک پہنچنے میں آسانی ہو۔
