6. Mr. Inayatullah, Mr. Khushdil Khan Advocate and Mr. Ghazi Ghazan Jamal, Hon'ble Members Provincial Assembly stressed to include all the projects that were left over from this Bill as they are also of perpetual nature projects.

7. Mr. Akhtar Saeed Turk, Special Secretary, Establishment Department told the committee that 121 projects had been scrutinized by the concerned departments and were included in the schedule of the Bill. He informed the Committee that scrutiny process was started in January, 2020 and completed in August, 2021. The Administrative Departments consulted during this period and upon their certification, the projects of perpetual nature have been included in the schedule of the Bill. The process of scrutiny has already been finalized and the Bill has been introduced in the Assembly.

8. Mr. Shumail Ahmed Butt, Advocate General, Khyber Pakhtunkhwa informed the Committee that all these employees will be regularized as Civil Servants of the Province.

9. The Committee agreed to with the suggestions advanced by the undersigned that let this Bill containing regularization of 121 projects employees in the schedule be passed as it is so that the employees of already scrutinized projects could be regularized. A departmental scrutiny committee has already been constituted to scrutinize the rest of 32-projects, proposed by the Hon'ble Members in their amendments.
