BILL
to repeal the Khyber Pakhtunkhwa
Delimitation of Local Councils Act, 2015.

WHEREAS the Election Commission of Pakistan has been empowered to delimit the village councils and neighbourhood councils for the elections of local councils in the Province of the Khyber Pakhtunkhwa under the Elections Act, 2017 (Act No. XXXIII of 2017);

AND WHEREAS pursuant to the above, the Khyber Pakhtunkhwa Delimitation of Local Councils Act, 2015 (Khyber Pakhtunkhwa Act No. VI of 2015), has become redundant and accordingly requires to be repealed;

It is hereby enacted by the Provincial Assembly of the Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Delimitation of Local Councils (Repeal) Act, 2020.
(2) It shall come into force at once.
2. **Repeal.**---The Khyber Pakhtunkhwa Delimitation of Local Councils Act, 2015 (Khyber Pakhtunkhwa Act No. VI of 2015), is hereby repealed.

STATEMENT OF OBJECTS AND REASONS

It is desirable to repeal the Khyber Pakhtunkhwa Delimitation of Local Councils Act, 2015 (Khyber Pakhtunkhwa Act No. VI of 2015). Hence, this Bill.
