ACT**

further to amend the West Pakistan Motor Vehicles Taxation Act, 1958.

WHEREAS it is expedient further to amend the West Pakistan Motor Vehicles Taxation Act, 1958 (West Pakistan Act No. XXXII of 1958), for the purposes hereinafter appearing:

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. Short title and commencement--- (1) This Act may be called the West Pakistan Motor Vehicles Taxation (Amendment) Act, 2021.

(2) It shall come into force at once.

2. Deletion of Schedule-I from the West Pakistan Act No. XXXII of 1958--- In the West Pakistan Motor Vehicles Taxation Act, 1958 (West Pakistan Act No. XXXII of 1958), hereinafter referred to as the said Act, "SCHEDULE-I" shall be deleted.

3. **Amendment of Schedule-II of the West Pakistan Act No. XXXII of 1958.**---In the said Act, for the heading "SCHEDULE-II", the heading "SCHEDULE" shall be substituted.
