لہذا یہ اسسبلی مرکزی حکومت سے اس کی پر زور سفارش کرتی ہے۔ کہ ایف بی آر کے افسران و اہلکاروں کو تاکید کی جائے کہ جو تاجر و دکاندار اس دائر کار میں نہیں آئے ان کو بے جا تنگ کرنے سے اجتناب کریں اور مذکورہ قانون کے تحت صحیح assessment کیا کریں تاکہ چھوٹے تاجروں و دکانداروں میں تشویش اور بے چینی کو ختم کیا جائے جاسکے۔“
