I am directed to say that the Provincial Assembly of Khyber Pakhtunkhwa in its sitting held on **07-06-2021** has unanimously passed the joint Resolution No.1161 moved by Mr. Mir Kalam Wazir, MPA and Mr. Shaukat Ali Yousafzai, Minister for Labour, Khyber Pakhtunkhwa as follow.
