**8. MOTION FOR ADOPTION OF RESOLUTION UNDER ARTICLE 144 OF THE CONSTITUTION OF THE ISLAMIC REPUBLIC OF PAKISTAN, 1973.** In pursuance of Article 144 of the Constitution Mr. Sultan Mohammad Khan Minister for law, moved a Resolution No.699 regarding regulating subject of Ruet-e-Hilal by Majlis-e-Shoora(Parliament) which was unanimously passed by the House.

**9. DIRECTION OF MR. SPEAKER.** Ms. Nighat Yasmen, Orakzai, MPA raised the issue of child marriage and murder of a 12 years old married girl in timargara, Dir, upon which the Hon’ble Speaker issued the following directions to concerned authorities/Departments:-

- a. Home Department shall furnish detail report regarding the said incident to Assembly Secretariat till 11:00 a.m of 14th July, 2020 positively which will be discussed in Assembly sitting on that day.
- b. Child Marriage Bill be placed before the Cabinet for approval in its next meeting.
- c. The Chairman, Select Committee on The Khyber Pakhtunkhwa Domestic Violence against Women (Prevention and Protection) Bill, 2020 shall submit its report to the House within a period of one month.
